### **Section A: JOINTLY DEVELOPED**

Parents were notified of this meeting through flyers, messages posted to students' Google Classrooms, as well as through School messenger (automated phone calls). This year, the parent input meeting was held on May 16, 2022.*

We will also provide and send home a copy of the Parent and Family Engagement Policy and school parent compact at that time. Parents will be notified by flyer, monthly calendar and School Messenger.*

Parent meetings, trainings, and workshops are held at various times of the day to accommodate all families and their schedules. All communications sent home are in the family home language. *Each Winter and Spring, parents are encouraged to attend a budget review meeting. At this time, parents can give input into how they would like to see the 1% Title I parent funds to be spent. Parent Involvement Funds will be directed towards providing workshop services to parents, based on their expressed interests or areas of need. It will also be used to deliver information to parents. This meeting was held on February 25, 2022.*

## **Section F: COORDINATION OF SERVICES**

NorthEast High School will, to the extent feasible and appropriate, coordinate and integrate parent and family engagement programs and activities with other Federal, State, and local programs, including public preschool programs, and conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children by:

*Actively maintaining a Home & School Association with an active School Advisory Council. The H&SA and SAC will have regularly scheduled meetings and will convene to make decisions on issues impacting students and families. Northeast also partners with a multitude of local organizations, business, and community partners to provide additional support for the whole family. TruMark Financial Credit Union promotes financial literacy and assists our students and families with opening credit union accounts. Bank of America also helps with opening checking and savings accounts. The in-school ELECT office provides services to students who are also parents, and their families. WES provides mental health services to students, and counseling to families. PATH provides behavioral health services to students and families as well. Multiple arts organizations we partner with have programming that incorporates families, such as the Philadelphia Museum of Art, The Print Center, Philadelphia Photo Arts Center, Pennsylvania Academy of the Fine Arts. Academically, many of our partners support our families as they navigate high school, the application process for college, and even provide financial aid and scholarships. Some include, Philadelphia Futures, the UPENN Young Scholars Program, Ellis Trust for Girls, and the Villanova University Young Women's Initiative. Parents are also made aware of the parent resource center the district maintains at 440 North Broad Street.*

## **Section G: BUILDING CAPACITY OF PARENTS**

NorthEast High School will build the parents' capacity for strong parent and family engagement to ensure effective involvement of parents and to support a partnership among the school and the community to improve student academic achievement through the following:

- Providing parents with a description and explanation of the curriculum in use at the school, the forms of academic assessments used to measure student progress, and the achievement levels of the challenging State academic standards; and

*Various workshops and trainings are offered to parents throughout the school year. Some of the topics being covered are English Acquisition, College Application Process, Student Information Services, and other topics to be identified. During the Annual Title I meeting, held each September, we share with parents the requirements of Title I, Part A, parent rights and responsibilities, the State's academic standards and state and local academic assessments. There are three report card conferences throughout the school year; November, February and April, with an evening conference offered in November. During these conferences teachers will discuss with parents how to work with educators and monitor their child's progress. These conferences also give parents an opportunity to learn more about the school curriculum and how to support student learning at home.*

## **Section H: BUILDING CAPACITY OF SCHOOL STAFF**

NorthEast High School will provide training to educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school by:

*Surveys are made available to parents during all events, meetings, and conferences. They are also available in the main office at any time. The results of the parent surveys are tallied by the Assistant Principal who will share the data with the SLC leaders. SLC leaders share the results to the rest of the staff during common planning time throughout the school year. Common planning is held every Tuesday and Thursday. In August, staff will be trained on how to communicate and work with parents as equal partners by the Assistant Principal.*
